Range Rules

- **A RANGE SAFETY OFFICER (RSO) MUST BE DESIGNATED WHEN ANY FIREARMS ARE ON THE RANGE** (even when only 1 shooter is present)
- THE RSO MUST BE A CURRENT MEMBER OF ARPC AND WEARING THE ORANGE VEST
- THE RSO IS AUTHORIZED AND OBLIGATED TO ENFORCE RANGE RULES
- RSO COMMANDS AND DIRECTIONS MUST BE OBEYED BY EVERYONE
- ANY CONFLICTS WILL BE RESOLVED BY THE RSO
- NO SHOOTING FORWARD OF THE FIRING LINE
- SHOOTING IS ONLY ALLOWED FROM A STATIONARY POSITION
- NO DRAWING AND FIRING FROM A HOLSTER OR CONCEALMENT
- NO LOADED FIREARMS PERMITTED ON THE BENCH WHEN THE LINE IS SAFE OR PEOPLE ARE DOWNRANGE
 - (NOTE: A REVOLVER WITH A CHARGED CYLINDER, REGARDLESS OF THE CYLINDER'S POSITION, IS CONSIDERED LOADED)
- EVERYONE MUST WEAR EYE AND EAR PROTECTION WHILE SHOOTING IS TAKING PLACE
- PERSONS **IMPAIRED TO THE SLIGHTEST DEGREE** BY ALCOHOL OR DRUGS ARE PROHIBITED FROM BEING ON THE PROPERTY.

THE **POSSESSION** OR CONSUMPTION OF ALCOHOL OR DRUGS ON CLUB PROPERTY IS STRICTLY PROHIBITED EXCEPT FOR ALCOHOL AT SPECIAL EVENTS AS AUTHORIZED BY THE BOARD OF DIRECTORS

This waiver shall be valid against claims made by my heirs, executors, administrators, next of kin, successors, attorneys in fact, assigns or legal representatives. I knowingly, voluntarily, and expressly waive, release, discharge, hold harmless ARPC and any of its agents, officers, directors, shareholders, employees, instructors, volunteers, or representatives and relinquish any and all claims I or my estate, my heirs, or any person claiming for me completely and without reservation as a condition of my membership or participation.
